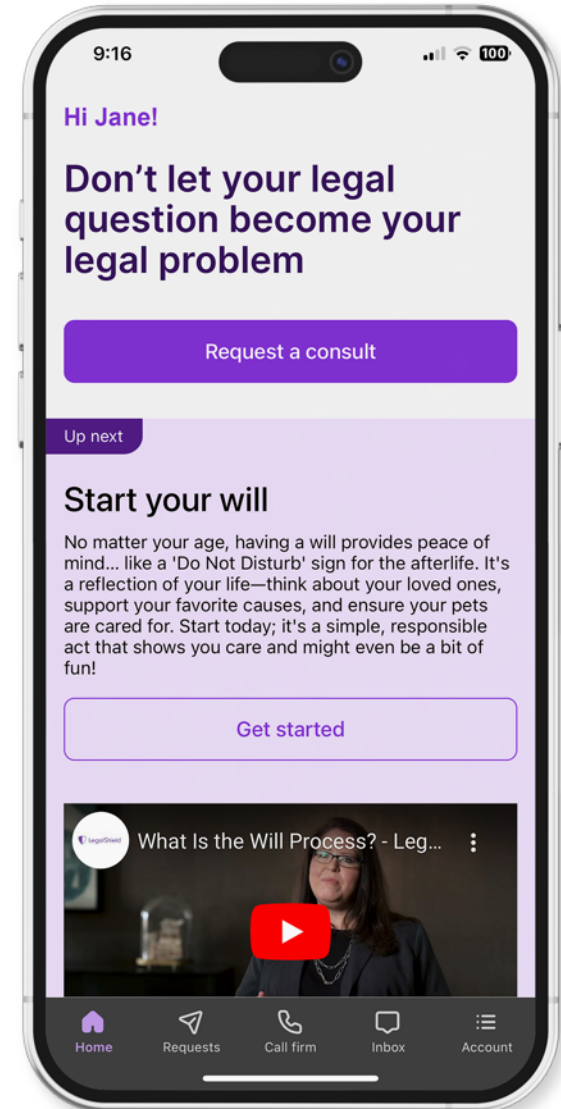

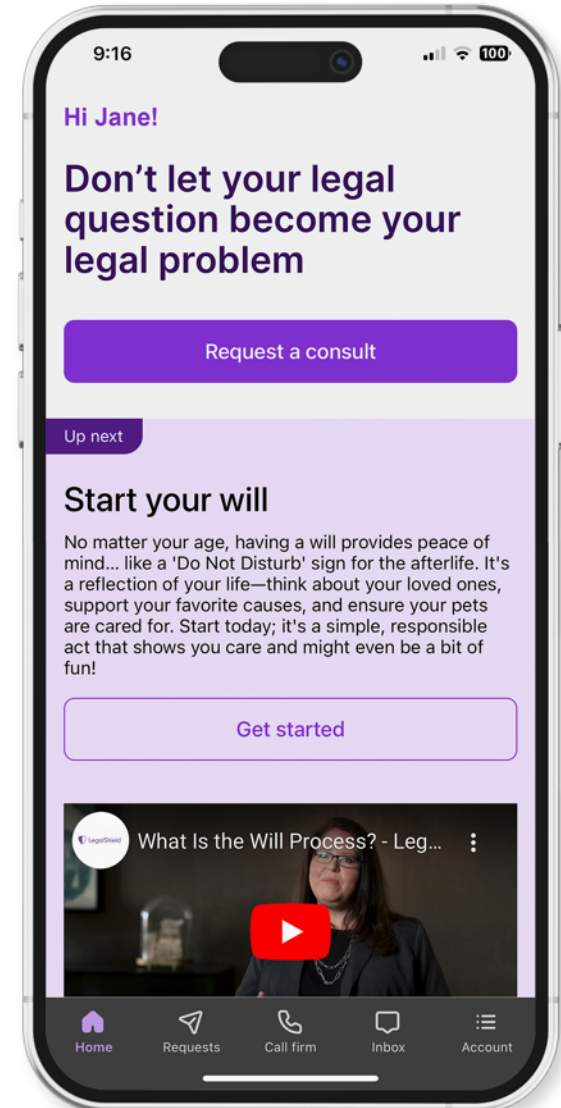

E-Signatures. Sign your electronic documents the legal way. Receive e-signatures if they are available for the document in your state. Up to 10 per membership year.

Collection Letters. A provider law firm can help collect money that's owed by writing collection letters, up to 4 per month. For additional letters, a flat fee of \$75 each applies.²

IRS Audit Legal Services. If your personal legal plan includes IRS Audit Legal Services, then your Home Business Add-on will also provide IRS audit coverage for help with items included on Schedules C and E of your personal federal income tax return. Business entity tax returns are not included.⁴

Document Review. A provider lawyer can review business legal documents. Every month, you can submit up to 4 documents of up to 25 pages in length. If you need more than four documents per month, a flat fee of \$75 for each additional review applies.³

Online Notarization. Legally notarize your documents and contracts online. Receive assistance with online notarization if available for the document in their state. Up to 3 per membership year.
